1. Fees As a general rule, students must pay the fees as follows: 1 Govan Mbeki Avenue, Central, Port Elizabeth, 6001

When registering the Application and Registration Fee with January 2023 fee must be paid. The annual fee was divided into 10 months.

The account payer has a choice: Either to pay in advance or to pay monthly by way of a Debit order. Fees are payable on or before the 1st of every month if the Debit order system is not utilised.

- If full payment is made in advance, then you qualify for the 25% discount on Tuition fees until 31 January 2023.
- 2. Late Payment

If fees are paid late, a penalty fee of R150 per month will be charged to your account. Unsuccessful debit orders are levied at R300 per month.

- 3. **Effective Date** These fees are effective from 01 January 2023 to 15 December 2023.
